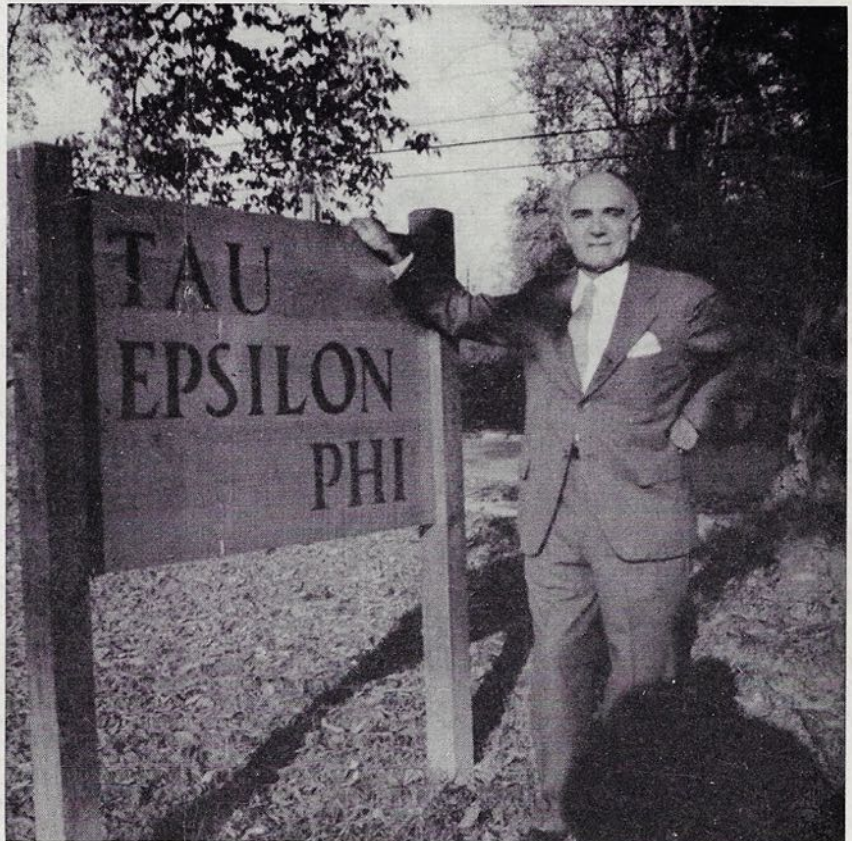

Awards Announced

IN one of the most dramatic contests in recent years, when the Awards Committee could not choose between two Chapters to be recognized as the outstanding Chapter of the Fraternity for the year 1963-64, the Committee decided to honor both as the recipients of the Irving Golembe Chapter of Merit Trophy.

Both Omega at North Carolina and Epsilon Eta at Drexel Institute of Technology had performed so outstandingly during the past year in every phase of fraternity activity that the Committee had no choice but to make them co-recipients of this, the most coveted award that the fraternity gives to a chapter. The problem of the Awards Committee in selecting recipients of the other awards was no less difficult. Each category had its host of Chapters who were eminently qualified to be recognized as the leader in that phase of fraternal activity.

In showing most improvement in every department of Chapter activity, the Committee selected Kappa Chapter at the University of Vermont as recipient of the Louis Lebenthal Chapter Improvement Trophy. Not only had this Chapter doubled its pledging over the previous year, but also had shown vast improvement in the management of the house, scholarship, and extra-curricular activities. Two other Chapters came within an ace of being named the most improved Chapter, namely: Epsilon Mu Chapter at Hunter College and Theta Chapter at Boston University, and were named runners-up and will receive plaques signifying this award.

In the competition for the Charles Driesen Chapter Efficiency Trophy, one Chapter stood out; it was Epsilon Iota Chapter at Rensselaer Polytechnic Institute. During the past year this Chapter had made thousands of dollars worth of improvement in its house strictly with the labor and in-

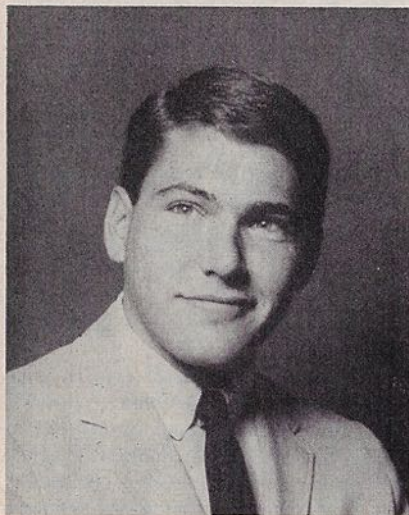
It was a fitting tribute to a TEP who has given so much of himself for so many years to his Fraternity

Brother Gibbs comes from a long line of TEPmen which include his father, his brother, a past Chancellor, and his uncle, a past Chancellor, to mention a few.

In addition to serving as Chancellor of his Chapter, Bro. Gibbs served in many different capacities in student affairs while attending F.S.U. He was for two years a member of the Student Senate, the student legislative body, and in his senior year he served as a member of the President's Cabinet as Attorney General of the Student Body.

As a leader of student politics on the F.S.U. campus, Bro. Gibbs, and Tau Epsilon Phi, became one of the founders of a campus political party, of which he was made Treasurer.

Bro. Gibbs was also active in Interfraternity affairs through his positions of Vice President and later President of the Interfraternity Council, and Chairman of the Greek Goddess contest.

As the crowning achievement to his four years of service to the University and his fraternity, Brother Gibbs was tapped into membership of Gold Key, the men's leadership honorary at F.S.U. and was also awarded a Meritorious Service Key by his Brothers of Epsilon Deuteron Chapter. He is a native of Tallahassee, Florida.

TEP Journalist Honored

AN outstanding TEPman in the field of journalism, Brother Jerry Landauer, Washington Correspondent for *The Wall Street Journal*, is the recipient of the Raymond Clapper Memorial Award and the award for Washington Correspondents given by Sigma Delta Chi, the National Journalism Society.

The stories which won the award for Brother Landauer dealt with conflicts of interest in the Federal Judiciary, particularly those ethical and practical questions raised by Judges becoming board members of banks, insurance companies, and industrial corporations. After his stories were published, the Judicial Conference of the United States barred judges from engaging in outside business ventures.

Dr. William Dameshek

Achieves Fame

In Medical Research

HIS belief in a medical concept through years of criticism and the perseverance to continue research on the basis of that concept has won a TEP alumnus important recognition in the medical world.

Boston Hematologist, Dr. William Dameshek, Lambda (Harvard), has been widely applauded for his efforts in pioneering the concept of autoimmune disease.

The May 1 issue of *Time Magazine* featured an article on Dr. Dameshek's work in the field of immunology and the development of his research. *Time* notes that it was in 1937 that Dr. Dameshek detected a clue that the body could produce

an antibody that would destroy cells in one's own body. Dr. Dameshek's colleagues scoffed at the concept, claiming the body could not develop such a mechanism of self destruction. In Dr. Dameshek's words, "For years we cried in the wilderness. We were called wide-eyed visionaries."

But through his own research and parallel developments, it soon became apparent that Brother Dameshek was on the right track, and that, indeed, the body could produce anti-bodies that would attack red and white blood cells, and entire organs, much as it does when it launches antibodies against foreign protein substances, i.e., viruses and

the like. Dr. Dameshek believes that this autoimmune or "auto-allergy" process is responsible for a number of familiar and sometimes fatal diseases. It has already been accepted that the autoimmune process can produce diseases of the eye, testicles, and thyroid gland, and some forms of anemia.

The *Time* article points out that medical researchers have associated a great number of diseases and pathological disorders with the autoimmune reaction, and that from the fruits of Dr. Dameshek's pioneering efforts it may be possible to develop cures or controls for a great number of diseases.

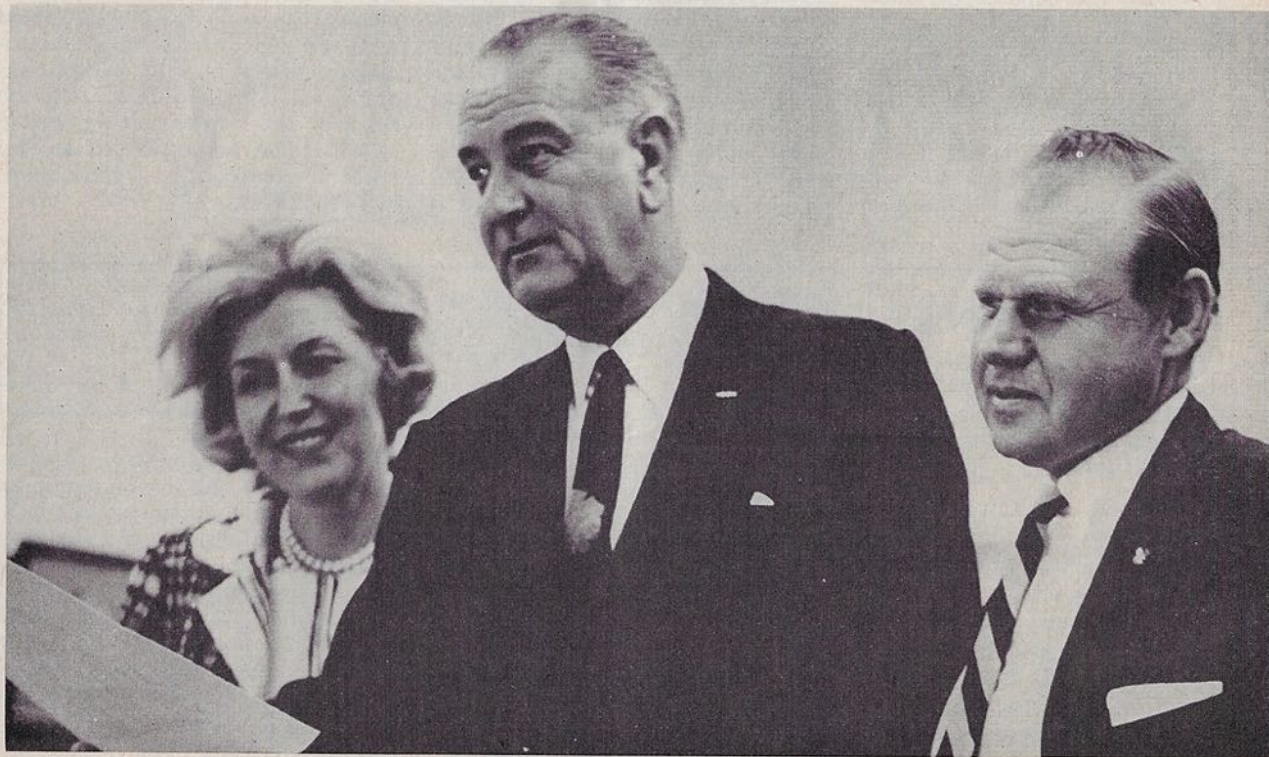
Brother Bob Nesoff, Public Relations Director of the Drive, expects to receive additional donations from the lagging Chapters following the

Tau Pi Room Named for J.F.K.

IN May of 1953, the late President John F. Kennedy, then Senator from Massachusetts, honored Tau Pi Chapter at the University of Massachusetts with a visit. This past April, Tau Pi paid homage to that visit and to President Kennedy.

A handsome wall plaque was presented to the Tau Epsilon Phi house at the Chapter's annual Parents' Day Ceremony to commemorate the Kennedy visit. The plaque was presented by attorney David Sokol who, as an undergraduate, was responsi-

ble for bringing J.F.K. to the University of Massachusetts.

Brother Sokol related to an audience of over 200 parents, Brothers, and their dates the details of the Kennedy visit. Mr. Kennedy, according to Brother Sokol, participated in a general discussion of world politics and remarked later that he was amazed at the extent of awareness the Brothers had in world affairs.

Senator Kennedy came solely for the purpose of participating in the

political discussion at the TEP house. It was his first trip to the University.

The Tau Pi Alumni voted to name the living room of the new Chapter house in honor of President Kennedy. Framed pictures and a copy of the letter received from Mr. Kennedy were presented to the Chapter by Merwin Rubin, President of the Alumni. The plaque and pictures will be mounted on the wall of the "Kennedy Room."

Brother Greene Is Top Bowler

BRO. Stuart Greene (Mu), a 20-year-old Emory University Senior, was one of 55 finalists from an original field of more than 13,000 bowlers who competed in the 1964 National Intercollegiate Bowling Championships in Oakland, California.

During the Intercollegiate Championships which took place on April

5-6, he finished 16 in singles, 26 in doubles and 46 in the all-events competition with a total score of 1516 for nine games.

Students representing 175 colleges from 11 different geographical regions competed in the 1964 eliminations in order to qualify for the 55 finalists berths.

A comparative newcomer to the ranks of Tau Epsilon Phi, Alpha Beta Chapter at American University, was named as the recipient of the Samuel Lefrak Campus Achievement Trophy for the outstanding qualities of leadership on the campus by its members. Among other accomplishments, this Chapter boasted of having the following B.M.O.C.'s; the president and vice president of the Student Senate; editor of the school newspaper; president of the IFC; president of the senior class; Junior Council representative; chairman of the Orientation Board; a member of the varsity basketball team; a member of the varsity soccer team; two members of the varsity golf team; chairman of the Elections committee of the university. In the field of intramurals, the Chapter won the softball and bowling championships and was second in intramural football.

Named as runners-up were: Tau Gamma Chapter at University of Southern California and Kappa Zeta Phi at Northeastern University. A perennial leader in scholarship attainment, Phi Eta Chapter at Johns Hopkins University again won the John Kleinberger Scholarship Trophy for leading all fraternities at Johns Hopkins with a cumulative average of close to B+. Also leading on their respective campuses in scholarship were: Epsilon Pi Chapter at Marietta College and Tau Lambda Chapter at Purdue University, who were named as runners-up.

For its campus and community service, including the outstanding feat of entertaining the Russian Circus in its house, Zeta Lambda Phi Chapter at Temple University was named the recipient of the Louis Fein Grand Chaplain Trophy. The two runners-up were Sigma Chapter at Syracuse University which organized and carried out a dramatic drive for the Eye Bank of the Medical School; and Delta Upsilon at Duke University for its dedicated work on behalf of the Lincoln Hospital in Durham, N. C.

The Chapter that had contributed the best material for publication in the PLUME was Epsilon Mu Chapter at Hunter College which was named recipient of the Charles Tobias PLUME Trophy. Runner-up was Rho Delta Rho Chapter at Illinois Institute of Technology.

The problem of choosing the individual award winners was no less diffi-
