# FRATERNITY BOYS HELP OUT

Reprinted from the New York Herald-Tribune Magazine, Sunday, February 25, 1962.

At the City College of New York these days, fraternity hazing is out and fraternity community service is in. For the Tau Epsilon Phi boys who volunteer at Knickerbocker Hospital, across the street from their Convent Avenue campus, the change is stimulating.

The boys are more than gray ladies in Ivy League dress. They not only assist in the wards, act as case aides in the hospital's social service department and organize recreational activities for patients, they also tell Knickerbocker about itself.

The hospital, a voluntary one serving the acute disease and emergency needs of Manhattan's Upper West Side, decided a few years ago to study itself as a social community.

With CCNY sociology professor Richard Brotman, the Knickerbocker administration worked out a program whereby the students would participate in, observe, and write reports on the life of the hospital.

Once a week, 30 weeks a year, Dr. Brotman leads a seminar in which the students and the hospital's department heads discuss Knickerbocker's problems.

Any CCNY student may join the program. Some now earn course credit for their volunteer work. The TEP boys signed up because they wanted "to do something worthwhile for a change." One outcome of the student seminars was a redesigned playroom outside the children's ward. And this year an alumnus of the program was hired on the hospital staff as administrative assistant.

"It works superbly," Knickerbocker director Alvin Conway says. "It recruits for the whole health field while it helps us."

# AS 55TH ACTIVE CHAPTER

In ceremonies attended by every TEP alumnus in Peoria and several from Chicago, Epsilon Tau chapter of Tau Epsilon Phi at Bradley Univ., became the "baby" chapter of the fraternity on Saturday, February 3, 1962. Representing the Grand Council were I. Edward Segal, Psi (Illinois), who presided at the induction ceremonies, Leonard Lauter, Psi (Illinois) Regional Consul who presented the charter to the new chapter, and Executive Secretary Sidney S. Suntag. A delegation of brothers from Rho Delt chapter at Illinois Tech put on the initiation and every TEP alumnus from Peoria took part in the ceremonies.

Following the initiation ceremonies, a banquet was held in the Sands Motel. Despite competition from the most important basketball game of the season between Bradley University and St. Louis University that evening, the banquet was attended by all in addition to Dean Edward King, Dean of Men of Bradley University. Serving as Toastmaster for the evening was Brother Julian B. Venezky, Tau Beta (Maryland) a former member of the Grand Council and prominent lawyer and businessman in Peoria. Brother Venezky is nationally renowned for his unselfish and devoted service on behalf of the National Cabinet of the Bonds for Israel. The highlight of the evening's festivities was the formal presentation of the charter to Chancellor Joel Blustein of Epsilon Tau, by Brother Leonard Lauter, Regional Consul. Other speakers in addition to Dean King, were, I. Edward Segal, Executive Secretary Sid Suntag, Alumni Advisor Sam Friedlander, Psi (Illinois).

Epsilon Tau was formed as a colony just a year ago almost to the day it was chartered. At the time the colony was reorganized by TEP it had a total membership of 6 men. In the intervening year, the chapter membership showed steady, if not spectacular growth. In September a

small house was rented at 1531 W. Fredonia, Peoria. This house was decorated, and furnished with the help of a loan from national and despite its small size, is most comfortable and attractive. The chapter now numbers 11 actives and four pledges soon to be inducted. There are no seniors in the group and only 2 juniors so their building in membership has just begun. One of the most gratifying aspects of this new chapter is the enthusiasm that the Peoria alumni have displayed for the group. These alumni, members of chapters from widely scattered regions have taken the group to their bosom. We look for big things from Epsilon Tau in the future.

and major officers, of the forthcoming convention.



### NORTHEASTERN


