# FROM THE BALD EAGLE'S NEST

In recent months much media attention has been given to the edict of one of our contemporary fraternities that is intending to do away with all hazing in their chapters. Inasmuch as most if not all hazing is perpetrated on pledges, the edict did away with the whole concept of pledging by making acceptable rushees instant brothers within two days. Although I agree with the fraternity's desires to end the practice of hazing, I must differ with the means used to reach that end.

First of all, attempting to end the practice by edict without full chapter approval can be self-defeating. One can well imagine the sub-rosa shenanigans that will take place — at times almost certain to be more dangerous than in a controlled situation.

I believe that only through education via seminars and constant pressure from National and local leaders can hazing be eventually eliminated. As a good example, not so long ago pledges in all fraternities were "punished" by being paddled. "Assume the position" was the cry from the brothers and pledges bent over to be hit by a long stick of wood appropriately engraved. Suffice it to say, serious injuries sometimes were inflicted. With education and constant pressure from fraternity leaders over the years, most if not all fraternity chapters have discarded this vicious practice.

For yet another reason do I differ with the aforementioned fraternity's solution to the problem. By making instant brothers of rushees after only two days, a disservice is being imposed on both the rushees accepted and the members of the fraternity involved.

It is a well-known fact that both members of a chapter and rushees put their best foot forward during rushing, no matter how long the rush period lasts. Therefore, in two short days, long before brothers and the rushees can get to know each other without the false face of rushing, instant brothers are made. One can well imagine what could happen if a rushee or rushees having paid their initiation fees, finds as time goes on that the members they thought they liked during rush, turn out to be individuals they would rather not associate with. The converse is also true.

I therefore believe that a period of instruction is necessary for both brothers and rushees before the first step of brotherhood is taken. The brothers must recognize that the candidate for brotherhood is there for two purposes only — to learn about the fraternity and to get to know the brothers better and vice versa. There is no place for hazing in such a relationship!



#### 1989 Grand Chapter Meeting In Review

With the theme "P.R.I.D.E." as special significance for its 79th Anniversary, TEP celebrated the occasion with an unusually successful biennial convention in Baltimore, Maryland. Under the leadership of Tau Beta (Maryland) alumni Co-chairmen John Smeyne '59 and Ed Raskin '52, delegates and alumni enjoyed four days of fun. Most importantly, however, the delegates produced many important innovations for the Fraternity in their deliberations during the business sessions, which were chaired by Grand Chancellor, Brother Ron Charpentier, Phi Sigma Chi (Cal Poly) '84.

The reader might well inquire the meaning of "P.R.I.D.E." in addition to its dictionary definition known to all, the letters spelled out yet another message to the brotherhood: P - Performance, R - Responsibility, I - Interaction, D - Devotion, and E - Ex-

cellence. There is no need to explain further the importance of this message, as it speaks for itself.

The Convention opened on Wednesday night, August 16th with a Welcome Reception in the Stouffers Harborplace Hotel, located in the heart of Baltimore's famous revamped harbor. Not only was every undergraduate delegate present, but many alumni joined in to kick off one of TEP's most memorable conventions.

Brother Jeff Perlow orchestrated the next evening's truly enjoyable and innovative event, a Crab Fest held in a famous Baltimore landmark, The Museum of Industry. For those uninitiated, which means most everyone who resides outside of the State of Maryland, a Crab Fest is a meal consisting of literally tons of hardshell crabs. The rest is chaos with each participant making use of wooden mallets to crack the crab's hard shells to remove the succulent white meat. Before long, hands, mouths and in some cases, clothes became a mess. Yet, it was grand fun and everyone enjoyed each minute of the evening. It will be long remembered.

The highlight of the Convention was the formal Honors and Awards Banquet. Following a sumptuous meal, Brother Arnold M. # Alumni Honored For Dedication and Service To Their Fraternity and Community

The feature of the Honors and Awards Banquet of the Baltimore Convention was the recognition of these alumni for their service to the Fraternity.

#### 1989 TEP Man of The Year

Brother Jack H. Pechter, Tau Beta (University of Maryland) '58, was honored at the Convention Banquet as "Tepman of the Year 1989," in recognition of his outstanding career in business, civic and religious affairs in his home city of Baltimore. As a survivor of the Nazi death camps, he arrived in Baltimore as a penniless refugee. From this humble beginning, Brother Pechter "arose from the ashes," working his way through the University of Maryland, to become one of Baltimore's most distinguished citizens. TEP is proud to have designated him "Tepman of the Year, 1989."

#### Michael C.C. Lilienfeld Distinguished Service Award

Brother Robert "Bobby" Glasser, Tau Alpha (Florida) '52, was awarded the Michael C.C. Lilienfeld Distinguished Alumnus Service Award. Brother Glasser was long overdue for recognition as one of TEP's most productive and hardworking alumni. He has always been at the beck and call of The Tau Alpha Chapter for assistance, beginning with the extraordinary chancellorship of his chapter. Later he designed, as architect, the current chapter house in Gainesville, he also found time to assist other chapters in the State of Florida.

Most recently, when the chapter house was in need of a major rehabilitation, Brother Glasser undertook the job of issuing the contracts for the renovations and commuted from his

home in Winter Park to Gainesville (some 150 miles) every week, supervising the work until satisfactory completion. In recognition of these extraordinary services, Brother Glasser has been awarded TEP's most prestigious service award. He "serves for the love of service."

#### 50 Year Citations for Fraternity Service

Brothers LEONARD WOLF, Tau Alpha (Florida) '39 and BEN ALPERSTEIN, Tau Beta (Maryland) '39, were honored with Special Commemorative citations for 50 years of service to the TEP Fraternity. Ever since their graduation from College, these alumni have been in the forefront in extraordinary commitment to TEP.

Brother Wolf, in addition to his devotion to his own chapter, Tau Alpha, had for almost 40 years been Advisor to the Tau Rho Chapter. More importantly, he has been one of the chief benefactors of The TEP Foundation, Inc., since its founding, aiding many needy undergraduates in the process. In 1981, he was honored by the Fraternity with the presentation of the Michael C.C. Lilienfeld Distinguished Alumnus Service Award.

Brother Ben Alperstein, a stalwart supporter of both his own Tau Beta chapter and the Fraternity for over 50 years, will be long remembered for his chairmanship of both the 1953 and 1969 Washington International Conventions, which proved to be among the greatest conventions ever held by the Fraternity.

Both of these brothers were honored for their half century of dedicated service to the TEP Fraternity.

# **Blumberg Elected Consul**

#### New Grand Council Installed At Convention '89

When Brother Stuart L. Blumberg, Tau Alpha (Florida) '58 finished his two-year stint as national fraternity Field Secretary (Director of Chapter Services) back in 1960, everyone knowledgeable in the fraternity was sure that he could eventually lead the organization as its International President. Through his dedicated leadership and devotion to his responsibilities (as amply described in THE HISTORY OF TAU EPSILON PHI in the chapter called "One Suit Stu"), he was considered the "wave of the future" in TEP. It took 19 years, however, for this prophecy to take place when Stu was installed in the office of Consul by his old boss, Sid Suntag, Executive Secretary Emeritus, at the Honors and Awards Banquet of the 79th Anniversary Convention in Balt-

After leaving TEP's employ in 1960, it was not surprising that Stu would succeed in the business world as his record of achievement indicates. Following his successful management of several hotels in the Miami Beach area, he was tapped to be Vice President by The Muss Organization, a noted New York and Miami building and real estate organization that claims the famous Fontainbleau Hilton Hotel as one of its properties, among many other noted hotels.

His leadership capabilities were recognized by others as well. He was honored by being named "Man of the Year" by the Miami Beach Hotel Owners Association. He is also now in his second term of office as President of the Miami Beach Chamber of Commerce.

While climbing the business ladder these past 19 years, Stu always found time for his fraternity in the State of Florida and particularly his beloved Tau Alpha Chapter. Whenever any chapter in the state needed help, Stu was always available to lend a hand. In 1985 he headed the call to chair TEP's 75th Anniversary Celebration

in the State of Florida and was responsible for the extraordinarily successful Founders Day Banquet that drew more than 300 alumni.

Most recently at a time of turmoil for Tau Alpha, he stepped forward to raise the necessary funds for a much needed renovation of its house. It came as no surprise that he was unanimously elected President of the Tau Alpha Holding Corporation.

The Fraternity is fortunate, indeed, to have Stu lead it for the next two years.

#### This is what we're doing about it:







A Special Tribute to a TEP Nobel Laureate

To read the curriculum vitae of BROTHER MICHAEL S. BROWN, Rho (University of Pennsylvania) '62, is to realize that he is one of the world's outstanding scientists. His record of achievement since graduation from Medical School in 1966 in the field of genetic disease marks him as one of humanity's most important benefactors.

He is currently Professor of Medicine and Genetics at the University of Texas and Director of the Center for Genetic Disease at the University of Texas-Southwestern Medical School, Dallas.

In the short period of 23 years since he left medical school, he has garnered an extraordinary number of honors and prizes, including the Nobel Prize in Medicine, which he (together with an Associate) was honored with in 1985. Most notable are the four honorary degrees he has so far been presented with from: Rensselaer Polytechnic Institute (1982); University of Chicago (1982); The Docteur Causa L'Universite de Paris-Sud in 1988; and his Alma Mater, the University of Pennsylvania in 1986. In 1987, in recognition of his extraordinary career, he was elected to the Board of Trustees of the University of Pennsylvania.

What is even more remarkable is that during his illustrious career, he has authored and co-authored no less than 297 articles and papers made available to medical journals and the medical profession as a whole.

Brother Brown is a Tepman who has truly "served for the love of service."

BROTHER EDWARD COHEN, Alpha (Columbia) '48 has been named winner of the 1989 New York Academy of Sciences Award in recognition of his extraordinary accomplishments in the field of civil engineering. Brother Cohen is the Managing Partner, Chairman and CEO of the engineering firm of Ammann & Whitney.

Brother Cohen has been responsible for numerous bridge, highway, mass transportation, aerospace, military engineering and construction projects in the world. Among his most recent noted works as engineer of record was the restoration of the Statue of Liberty in 1986, the Roebling Delaware Aquaduct Suspension Bridge in 1987, and the West Front of the U.S. Capitol Building in 1988. Some of his past projects include the Verrazano Bridge (New York), the redecking of the Golden Gate Bridge (San Francisco), the Pittsburgh Arena, Lincoln Center (New York), Washington's Dulles Airport, the Washington, D.C. Metro, among many others. His current projects include major bridge rehabilitation, a tollway in Southeast Asia, U.S. embassies overseas, airports, and buildings of all types.


# Denmark Elevated to the N.I.C.




